## Tabiona Community Fitness Center Member Agreement

In consideration of the mutual covenants and conditions contained herein, the parties agree as
follows:
1. Fitness Center is open from 4:00 am – 12:00am.
2. New membership or membership renewal can be acquired from the front desk at the school
during normal school hours, or from the Tabiona Town secretary on Tuesdays and Thursdays
during normal business hours.

Member agrees to hold the Center and any employees or contractors thereof harmless from any harm or injury received by the member, his/her family, his/her guest and any other person as a result of members use of any of the equipment or property located at the center, whether belonging to the Center or some other person, and shall indemnify the Center, its owners and any employees or contractor thereof for any expenses or costs resulting there from.
- 12.Member, his/her family and guests shall exercise a reasonable degree of care and caution with respect to the use of the Center equipment so as to avoid harm, damage, or injury to any of the property or equipment belonging to the Center and any other person. Any such harm, damage, or injury caused by negligence internal or willful misconduct to the member, family or guest shall be that member's sole responsibility. The Center shall not be the bailey nor assume responsibility for any property belonging to member family or guest used or leased at the Center.
- 13. No membership in Center may be reassigned or transferred.
- 14. You, the consumer, may cancel this contract at any time at which your card will be immediately deactivated.
- 15. In the event of rule breaking, incident, or accident, the following will take place:
  - o A written or verbal report will be made to a member of the Center.
  - o Prior to the next Town Council meeting, two (2) members from the Tabiona Town Council will review the footage together. (No separate/private recordings are allowed)
  - o Upon a review of the footage, the Center will determine if membership disciplinary action is necessary. (Membership discipline is described as warnings, suspensions, and revocation of membership)
  - o Any warning, suspension, or revocation is sent as a letter via certified mail to the membership card holder address.
- 16. The discipline process is as follows:
- 1<sup>st</sup> offense = Warning, 2<sup>nd</sup> offense = 2-week suspension, 3<sup>rd</sup> offense = 3- month suspension, 4<sup>th</sup> offense = membership termination
- 17. Members are welcome to use the lockers and the showers as part of their membership. The Center is not responsible for anything that is lost or stolen.
- 18. The Center reserves the right to cancel the membership of any member at any time. If, in its sole discretion decides the member, members family or guests do not conform to the standard of conduct set forth for the members. The Center is not obligated to refund membership fees paid.
- 19. This contract contains the complete, final, exclusive agreement of the parties with respect to the terms hereof.

## Tabiona Community Center Fitness Room Rules
