Mayor John Breakfield called the meeting to order at 6:01 p.m.

**Dalas Jones makes a motion to approve December minutes as written, Terry Hughes seconds the motion. All in Favor.**

The Fitness Center Committee was not in attendance.

Segregation of Town council duties. The council agreed to leave duties the same and just switch out new Council member names for the same duties. (See Attachment)

Strata Network representatives updated the Council on upcoming projects and the funding guidelines through the reconnect program. They stated that they received funding to take fiber optic up Tabby Mountain and the next project they are looking at would be Tabby Lane.

No new updates on the Civco Sidewalk Project.

Lacey Giles informed the Council what the State was requiring for the Water Source Protection Plan to be complete. Megan Jensen from Rural Water came out and assisted with what was needed for the update. They provided a map and said that anyone who had a structure in the water source protection boundary will need a letter and information sent to them, which is provided by Rural Water. Lacey was unsure on how many structures were in that boundary. Dalas Jones agreed to come and help

take a look at the map and boundary to help locate which landowners would be required to receive the information.

Christmas Tree lighting was discussed. Council agreed that a metal wire led lighted Christmas tree display would be better instead of planting a permanent tree. The Town does not own the 3-corner piece, so a permanent fixture is not suitable. Multiple trees and displays were considered.

**Makayla Pippy makes a motion to allocate \$3000.00 for 17' Christmas tree and two light up candy canes. Tanna Lee Strébel seconded the motion. Mayor John Breakfield abstained. All in favor.**

Financial review and approval of checks.
