Lacey Giles said she would order some extra testing supplies and go and test the water at their house. McCluskey's also voiced their concerns about Civco and the sidewalk project. They feel that in front of their residence is not put back the way they had promised to do so. Terry Hughes said he would talk to Civco when they do the walk through.

Nate Langston from Rural Water updated the Council and Lacey Giles on all that was needed to get current with culinary water issues. He also talked with Lacey about getting her certification and said that Rural Water was

willing to help in any way needed. As per Lacey Giles' hiring agreement she has until August to become completely certified as a water operator. Nate stated that the Fall Conference August 25-28 would be the next in person training and certification. He also stated that she could get certified online if she wanted to do it that way. Lacey said she would be on vacation during the fall conference and would try to certify online before that date.
