

## **Town of Tabiona Council Meeting & Public Hearing**

**Tabiona Town Hall**

**Tabiona, Utah**

**November 11, 2025**

Mayor John Breakfield called the meeting to order at 6:01 p.m.

**Terry Hughes makes a motion to approve October minutes as written, Tanna Lee Strebel seconds the motion.**

A discussion took place regarding recent concerns about shower usage at the community center. During the conversation, participants reviewed current practices, identified areas where improvements may be needed and shared feedback on how to ensure facilities are used safely, respectfully, and in a way that meets the needs of all members. The goal of the discussion was to promote clear expectations and maintain a comfortable, well-managed environment for everyone who uses the center. Item will be on December's agenda for further discussion and possible motion. Darin Jenkins stated that there is a need to install an ADA compliant door to the community center. He said that the school district would be willing to install the door, but they are very expensive around \$14,000.00. He is asking if the Town of Tabiona would be willing to cover half of the cost for this door. Darin Jenkins will get cost, and it will be made as a motion item for the December meeting.

Jessie Stegmeier presented Tabby Tails non-profit organization dedicated to supporting animal care and providing affordable and convenient spay and neuter services. Jessie highlighted the group's mission to reduce pet overpopulation, improve overall animal health and assist community members who may not have access to traditional veterinary resources. They explained how the organization partners with local shelters, volunteers and veterinarians to offer low-cost procedures, education and outreach programs. The presentation emphasized the positive impact these efforts have on both animals and the community. The Tabby Tails is asking for the Town to allow them to use the Town Hall free of charge on Thursday evening for their bingo fundraiser.

**Terry Hughes makes a motion to allow Tabby Tails to use the Town Hall free of charge on Thursday nights for the non-profit organization until the end of March 2026, Makayla Pippy seconded the motion. All in Favor.**

Jeff McCarty provided an update on the water project and the easement meeting with the BIA. Terry Hughes and Dalas Jones were also in attendance at the BIA meeting. He said the meeting went well however they did not come to an agreement because the full council was not in attendance for the BIA. Jeff stated that the BIA asked him to write up our proposal and submit it. Jeff presented a document for the Council to review and have a lawyer review. He said the tribe does not want money for the easements but may be willing to trade for 5 culinary water hook-ups per parcel for 5 perpetual easements.

Water operator Tim Teto said he was working on the lead and copper requirements. He also has a company that is going to come out and give us a bid to replace the fire hydrants and funding options associated with that. He would like the council to find a replacement for him by January.

Financial review and approval of checks.
